I assert that I am physically fit to ride on a boat and I will not hold the vessel "GTG1" and/or **GODS ANGLERS LLC / Eric Alexander** or their employees, agents or other associated personnel responsible if I am injured as a result of **ANY** problems (medical, accidental or otherwise) which occur while chartering the boat or otherwise participating in the trip.

I fully understand that the vessel "GTG1" has limited medical facilities and that in the event of illness or injury, appropriate care must be summoned by radio and treatment will be delayed until I can be transported to a proper medical facility. I agree in advance to these conditions.

**GODS ANGLERS LLC / Eric Alexander** and vessel "GTG1", have made no representations to me, implied or otherwise, that they or their crew can or will perform safe rescues or render first aid. In the event I show signs of distress or call for aid, I would like assistance and will not hold **GODS ANGLERS LLC / Eric Alexander** or vessel "GTG1", their crew or passengers responsible for their actions in attempting the performance or rescue of first aid.

**GODS ANGLERS LLC / Eric Alexander** is not responsible for any evacuation or assistance cost in case of emergencies, clients will be responsible if such medical assistance is needed.

I agree to forever discharge and release **GODS ANGLERS LLC / Eric Alexander**, vessel "GTG1", its employees and agents, the owner(s) of **GODS ANGLERS LLC / Eric Alexander**, vessel "GTG1", and affiliates, from any and all responsibility or liability for any and all injuries or damages. I agree **NOT** to make a claim against or sue any of the above parties for injuries or damages whether they arise or result from any **NEGLIGENCE** or other liability, **EVEN IN CASES OF GROSS NEGLIGENCE**. I further specifically agree, on behalf of myself, my heirs and assigns, to indemnify and hold harmless the released parties for any and all causes of action arising as a consequence of any incidents which might occur as a consequence of my participation in any activities with or involving the released parties.
